### **NEWEST PROJECT — BENCHES!!!**

#### WHEN WILL THE TRAIL ALONG CRYSTAL LAKE BE PAVED ???

This is the most common question we are asked. The simple answer; when the property owners along Crystal Lake want it paved.

A brief bit of history: When the Ann Arbor Railroad failed, the Michigan Department of Transportation bought the property and operated the railroad for a few years to support rail dependent jobs, including manufacturing jobs in Cadillac, Owosso, etc. But the State lost millions of dollars each year and, in 1988, decided to abandon the railroad. Owners of property adjacent to the railroad along Crystal Lake between Beulah and Mollineaux Rd. sued the state for ownership of the property. The State acquiesced and agreed to sell the property under terms which would have eliminated any public trail west of Beulah.

In 1994, when we (FBVT) learned that we were about to lose the Trail, we petitioned to intervene in the lawsuit. We were soon joined by Benzie County, Crystal Enterprises and the DNR as intervening defendants. Over the next 18 months we negotiated a Settlement Agreement which gave us less than we had hoped for but did

Now that the Trail is completed to Thompsonville, we are devoting our efforts to projects that protect the Trail and make it more enjoyable. Last year, mile markers were fashioned and installed. Last spring, a retaining wall was constructed near the Turtle Ponds and steps were built on the Elberta Causeway to prevent erosion of the shoulders and subsequent destruction of the asphalt trail.

Now, we are concentrating on benches. During the summer, members of the Benzie Audubon Club, with materials furnished by FBVT, placed timber beam benches, with backs, on the Observation Deck on the Elberta Causeway.

This fall a much more ambitious project was started, funded entirely by FBVT i.e. your contributions. Eight scenic sites between M-115 and Elberta were selected for placement of Wabash Valley plastisol-coated steel benches. Railroad tie structures ("bumpouts") were constructed adjacent to the Trail and filled with aggregate to create flat surfaces for the benches (at eleven hard man hours per "bumpout" !!!). One bench ("Jim's bench") has been placed at the Lewis Bridge Overlook. Next spring, after the aggregate has settled, the remaining seven will be placed, their in-ground legs encased in concrete. Other benches may be placed later.

Many thanks to all of the volunteers, for their work on these projects !!!

assure a permanent, non extinguishable, easement for a public trail from Beulah to Mollineaux Rd. This satisfied the DNR to the point that they purchased the corridor from 10th St. in Frankfort to Thompsonville and formed the partnership with Benzie County which has allowed us to build the Trail we now so much enjoy. If we had not prevailed in the lawsuit, the DNR would have purchased only the corridor from Beulah to Thompsonville, leaving it undeveloped (no resurfacing, no bridge renovation, etc.) for a snowmobile trail.

So why can't we pave the Trail along Crystal Lake? Because the Settlement Agreement includes several restrictions which were hard for us to accept, such as an easement too narrow to allow proper sight distances and shoulder maintenance and, especially, the statement that "This portion of the trail shall not be paved by concrete, asphalt, or similar paving material". So it remains as it is; the only part of the Trail about which we receive complaints.

However, the Settlement Agreement may be amended if all of the parties agree. The only parties opposing paving are owners of property adjacent to the Trail along Crystal Lake between Beulah and Mollineaux Rd. A growing number of these property owners are using and enjoying the Trail and have indicated an interest in seeing this section paved. We plan no action to amend the agreement. That is up to the property owners. But paving this section of the Trail remains a high priority with us and, when the plaintiffs decide they want this section paved, it will happen!!!

#### **VOLUNTEERS NEEDED**

We need volunteers to help with Trail construction projects such as placing benches, replacing signs and repairing minor damage to the shoulders. #### JIM'S BENCH

Jim Honchell was a special guy and a wonderful friend of the Betsie Valley Trail. He was a member of our Board of Directors, our representative on the Trailway Management Council, an ever welcome source of wise council and advice and a very dear personal friend to many of us. When he died suddenly on July 5th his friends wanted to do something meaningful for the Trail in his memory. Accordingly, their memorial contributions were used to buy the first of the new benches and, on October 10th, a few of his friends installed it at the Lewis Bridge Overlook. Since DNR regulations prohibit memorial or donor plaques on benches, it will bear none. But those of us who knew him will always consider this "Jim's Bench" and think fondly of him as we pass or sit on it with its beautiful view of the Betsie River.


