# MDOT BIKEWAY INITIATIVE A WIN FOR BENZIE COUNTY

If current planning and funding proposals prevail, we will have an interconnected system of paved bicycle pathways in western Benzie County.

The Michigan Department of Transportation (MDOT) has long advocated for and facilitated nonmotorized transportation and has been a strong supporter of bike trails. When it makes major improvements to existing highways, such as the recent renovation of M-22, a 6 foot paved bicycle lane is added on each side. When the new US-31 bridge in Beulah was built a few years ago, a separate arch for the Betsie Valley Trail was included. And MDOT provided \$348,900 in grant funding for construction of the Betsie Valley Trail between Frankfort and Beulah.

Last winter MDOT funded a statewide project to determine each County's desires for bicycle lanes beside existing highways to give them guidance for construction as funding becomes available.

We are very pleased with the proposal for Benzie County. It includes bicycle lanes beside Deadstream and Platte Rds. to Honor, encircling Big Platte Lake. Also included are Crystal Dr. on the north side of Crystal Lake and South Shore Dr. and Shorewood Dr. on the south. Since M-22 and M-115 already have bike lanes, this would provide a safe route completely around Crystal Lake. We applaud MDOT's efforts and plans.

Our priority has always been to complete as much trail surface as funding would allow and leave trail "amenities" until later. Since we have no Trail to build right now, we've been concentrating on projects to enhance Trail user's enjoyment and safety.

Benches came first. Last fall volunteers placed one bench and built railroad tie aggregate filled "bumpouts" between Elberta and M-115 to create flat surfaces for seven more. This spring the remaining seven benches were placed and they are being enjoyed. This project cost almost \$6,000, funded by your FBVT contributions, and required over 200 hours of volunteer effort.

The next project involves the need for improved parking at River Rd and Mollineaux Rd. BVTMC is working with the DNR Fisheries Division, owner of both properties and, with FBVT funding, has hired Dean Sandell to prepare preliminary plans for consideration by BVTMC and the DNR. Dean was the DNR Trail representative as the Trail was built, so is very familiar with the Trail and its needs.

The off road parking space at Mollineaux Rd. is too small. On busy days cars park and unload bikes and children on Mollineaux Rd., a dangerous situation. FBVT and BVTMC propose the plan shown on page 2. This plan will allow those using the Trail and the Crystal Lake beach to access the Trail directly, not via

Mollineaux Rd. This "Outlet" property was purchased by the DNR for the proposed Crystal Lake boat launch. Because of local opposition to a launch at this site, the DNR purchased the Labadie property to the east for the launch. As part of the development of that property a wetland mitigation will be required, and this is proposed for the "Outlet" property. Development of the Labadie property is currently delayed in a permit Administrative Hearing process and an Appeal to a Circuit Court decision. Until decisions are made regarding the launch site and the mitigation, planning for parking at Mollineaux Rd. will have to wait.

We would like to start planning for the River Rd. parking lot this summer. This is a busy lot, serving both the Trail and the Betsie River boat launch. There is severe erosion of the sand parking area and the deteriorated DNR launching ramp should be replaced. We will work with the BVTMC and the DNR toward construction of an approximately 135 ft. x 55 ft. aggregate parking area and a new launching ramp. The DNR planning and permitting process takes a long time. We will keep you informed.



# TRAIL IN EXCELLENT CONDITION

We are very pleased to report that the Trail has never looked better, thanks to recent changes in the mowing and volunteer programs.

For the past three summers the shoulders of the Trail from Frankfort to Thompsonville have been mowed twice a year by the Benzie County Road Commission under a contract funded by FBVT. The BCRC uses the same large tractor and mower it uses on road shoulders and the improvement is impressive. The "cut" is 5 ft. wide and produces a nice contrast between the trimmed shoulder and the wild growth. We are impressed how well grass and wild flowers flourish on the cut shoulder. We expected that the mowing would control woody growth, and it does, but it also controls the 'snake grass" and poison ivy surprisingly well. There has been expressed concern about the use of herbicides to control the noxious weeds. We find that this is not necessary. In fact we use no herbicide except some Roundup (several applications a year) to try to keep the willows under control in a couple of short segments near Frankfort. These willows are going to be a continuous problem and some of the damaged trail will have to be replaced eventually.

Thanks for the second big improvement goes to our volunteers. Each spring, crews drive the trail with chain saws and remove trees and branches which have fallen during the winter. Then our Adopt-a-Trail groups walk the trail to pick up debris and throw off branches. And Bill Olsen uses his tractor and FBVT's powerful blower to blow the debris and sticks off the Trail as needed.

### **BYLAWS AMENDMENT**

The Proposed Amendments to Article XI, Section 4 of the FBVT bylaws on the other side of this page have been approved by our Board of Directors. We urge you to read them. They will be discussed and voted upon at our annual meeting in July.

The Board believes these changes are needed because DNR funding is no longer sufficient to properly maintain the Trail. The proposed changes will allow FBVT to provide funding for specific projects our Board approves. We have built a beautiful Trail and we want to keep it that way. We urge your support these changes to our bylaws.

### **Proposed Amendments to Article XI, Section 4**

Strike thru = delete; Double underline = add

Sec. 4 Accounts. The Corporation will maintain Operating, Capital and Endowment Fund accounts.

- a. Operating Account. The Operating Account will consist of funds to be used to conduct the business and operating functions of the Corporation. All membership and other non-directed contributions will be deposited in the Operating Account. All income not specifically directed to another account or fund will be deposited in the Operating Account.
- <u>b. Capital accounts.</u> Capital accounts are established to provide funds for construction and/or capital improvements to the trail and/or related amenities as determined appropriate by the Board of Directors. The profits from fund raising activities, donations designated for specific trail related projects and donations designated for specific capital accounts will be deposited in interest bearing accounts. Funds may be transferred from the Operating Account to capital accounts by the Board of Directors. Funds in the Capital accounts may not be deposited or transferred to an Operating account, the Betsie Valley Trail Fund or used to conduct the business or operating functions of the Corporation. It is intended that capital funds will be leveraged as far as possible i.e. used only as a portion of the local match for projects which qualify for grant support, but exceptions may be made by the Board of Directors.
- c. Betsie Valley Trail Fund. The Betsie Valley Trail Fund is an operating account established to provide funds to purchase materials, supplies, tools, equipment and/or contracted services as determined appropriate by the Board of Directors. The profits from fund-raising activities and donations specifically designated for this fund trail maintenance will be deposited in an interest bearing account. this Fund and will be used only for the purposes stated above. Funds from the Operating Account may be transferred to this account by the Board of Directors. All expenditures from this account must be approved by the Board of Directors. No part of these funds will be transferred to any other organization except to fund specific projects or purchases as approved by the Board of Directors.
- d. William R. Olsen Leadership Endowment Fund. The William R. Olsen Leadership Endowment Fund is established to provide a continuing source of income for physical improvements to the trail and for specific needs as approved by the Board of Directors. The principal will consist of contributions from memorial, honorary, deferred and other gifts specifically designated for the William R. Olsen Leadership Endowment Fund and will be invested in a separate designated interest bearing account. The principal will remain intact. The interest and dividends may be withdrawn and transferred to a capital account or to the Betsie Valley Fund by the Board of Directors.
- e. Funds will not be used to operate or maintain any portion of the Betsie Valley Trail or related portions of the Betsie Valley Trailway complex except for funds in the Betsie Valley Trail Fund.

### EDUCATIONAL RAIN GARDEN AT THE BEULAH TRAILHEAD

Thanks to a \$1,515 grant from the Friends of the Betsie Valley Trail, all elementary children in Benzie County can learn about and participate in planting a rain garden by the Trailhead depot in Beulah on Monday, June 23 from 10 am to noon. The project is named The Garden of Possibilities.

The rain garden will be an attractive addition to the Beulah Trailhead and an important educational tool. The deep roots of a rain garden's native plants soak up about 90% of the pollutants in run-off water they contact, cleansing it before it enters a storm sewer, lake, or river. Other rain gardens have been built in Grand Rapids and Kansas City.

There has been strong community support for this project. Karen Dahman, a retired teacher trained by the National Geographic Society, has spearheaded the project assisted by Carolyn Thayer, landscape architect, Bev Toomey of Ohio State, Judy Groulx with Texas Christian University, and Meredith McNabb of Bayside Printing. Jim Gillison, Bill Huddleston, and Darwin Johnson have prepared the garden bed and have installed some large garden boulders. Tom Hopkins, Honor Building Supply, will supply a fence at low cost and Dean Chamberlain and Neal Boynton will install the fence and garden sign. Sculptor Kevin Short of Honor is donating a flower bouquet sculpture for year round color.

The garden has been arranged by a team of Benzie Central High School students selected by Raquel Huddleston, science teacher. Volunteer high school students and members of the Lakeshore and Periwinkle garden clubs will help the children build the garden. There will be an evening of donor appreciation and public information on Thursday, July 24, 7 pm at the garden.

After the garden planting there will be a series of environmental classes concerned with water on Monday mornings from 10 am to noon, sponsored by the Crystal Lake & Watershed Association. Please call the CLWA at 882-4001 for additional information.

In the beginning... the DNR partnered with Benzie County to establish the Betsie Valley Trail. The DNR provided the rail bed for the Trail, and the County agreed to maintain and operate it. As the County took on this responsibility, they created the Betsie Valley Trail Management Council – an agency of the Board of Commissioners charged with managing, operating and maintaining the Trail. A new partnership was created.

The Betsie Valley Trail Management regularly partners with our group – the Friends of the Betsie Valley Trail, to make things happen on the Trail. Our Trail Care Coordinator coordinates volunteers for construction projects, Trail cleanup, and a range of other activities. And, for some projects, the Friends group supports the County financially when grant requests for special projects are submitted and approved by the Friends Board. As an example, look for the improved and enlarged parking areas to be completed at Mollineaux & River Roads.

Every one of you is a partner through your membership investment, and many of you have also pitched in by working on Trail projects or participating in events. Thank you!
